Please be sure your application is **FULLY** complete and **LEGIBLE** (for ALL members of the party) before mailing, as you will **not** be notified if your application is ruled invalid for illegibility and/or being incomplete.

This application must be received by the close of business on Monday, April 27th, 2026. Applicants will be notified with the results of the drawing as soon as possible. This could take a couple of weeks, so please do not call the office to receive results of the drawing until May 18th.

Please type or print your application and include **ALL** requested information. Customer numbers are assigned and printed on the license when you buy your first license with the state of Illinois and never change. If you have never hunted in Illinois, you can buy a Habitat Stamp online, which will secure you a customer number and enable you to participate in the drawing.

Up to three partners will be considered if indicated on the application; however, this application will also be considered the partner's official application. If any hunter's name appears on more than one application, the application will be rejected. Mail only one application per envelope. All applications must be received in a sealed envelope marked "Non-Resident Archery Deer Hunt".

To be eligible to hunt, you must have in your possession a valid Illinois Non-Resident Archery Deer Permit, a Non-Resident Hunting License, a Habitat Stamp, and a Windshield Card (windshield cards can be obtained online at: dnr2.illinois.gov/windshieldcard/).

Statewide hunting regulations will be in effect, including the following site-specific rules:

1. No hunting will be permitted within 100 yards of any developed area.
2. Tree stands must be portable and only one left in the field at a time. No screw-in steps are allowed. Stands left in the field **MUST** be tagged with name, phone number, and address of permit holder.
3. Permits are not transferable.
4. No motorized vehicles of any kind allowed off-road on site.
5. Deer must be *immediately* tagged upon being harvested.
